Efforts to Prevent Aquatic Invasive Species (AIS) Infestation

We have been working closely with the DNR, ACLARA, Aitkin County Soil & Water, etc. to help prevent Aquatic Invasive Species (AIS) infestation. We have applied for another grant. This year the lake association match will drop from 20% to 10%. Last year your FILIA paid \$2,903 for their 20% match. The FILIA board members voted to spend no more than \$1,600 this year in its collective efforts with the DNR and Aitkin County Soil & Water.

The AIS decontamination units are staffed and located at Minnewawa, Big Pine, and Spirit Lakes. During the week, the units are staffed by FIRM on Hwy 169 Aitkin and Willey's Marine on Hwy 65 in McGregor. Stop in to thank them for running the decontamination units during the week, storing those units, and being very supportive of the AIS effort.



AIS Report to FILIA, June 4, 2016

After one full year of open water season (2015), using paid DNR trained inspectors at both north & south public access point - we see great improvement in compliance with current law to curb Aquatic Invasive Species. We are less concerned with Eurasian Milfoil now and we know that Zebra Mussel invasion is our biggest threat. Aitkin County had over 8,000 boats inspected with the largest number at Farm Island Lake with 1,756. Only a few boats were referred to one of the decontamination units to be sprayed with hot water. That only means that those boats were a "high risk".

Mid-summer of 2015 we had tested for juvenile Zebra Mussels and found none. We are a high priority from the DNR's perspective and will continue to have intense coverage. We applied for 1,288 hours of inspection for 2016 and were given 864. Inspectors are using computer 'notebook' devices for recording data at the inspection points which will improve usefulness of information at the end of the season. If we use all of the inspection hours allocated to us for the 2016 season, our 10% matching expense will be only \$1,555.

Opening fishing weekend saw cold & windy weather with less than usual boat activity, but all partner lakes had full inspector coverage. We had coverage Friday for 8 hours and Saturday and Sunday 12 hours. Memorial Day weekend was extremely busy with both north & south landings covered Friday, Saturday, Sunday and a partial day on Monday. Aitkin County hired 30 inspectors for the season knowing some would quit so there are at least 24 inspectors to cover all partner lakes and some random lakes who did not submit for a Grant or are too small to have a lake association. The weekend of June 4 & 5 had full coverage with decontamination units at Minnewawa, Big Pine and Spirit. During the week, the 'decon' units are staffed at Willey's Marine in McGregor and F.I.R.M. near FIL.

As the water gets warmer, the AIS risk increases. By now, the staff of inspectors has had a chance to get up to speed with the process. The Sheriff's department is in full support of our efforts for AIS control and there will be a random presence at all landings in the county.



Results of careless dumping of hot ashes

Fire caused by **dumping left over hot ashes** in a low area on the south end of Farm Island Lake resulted in an acre of fire damage. It just about reached to Tame Fish Lake Road. The Aitkin Fire Department and the DNR put out the fire.



News from the DNR

The DNR will be doing a population assessment of fish on our lake this summer. This will probably take place during the third or fourth week in July.

2 unhatched eggs from a nest were turned in to the DNR Loon Guy (out of Garrison). The eggs were sent out East for evaluation, and we are awaiting results from the testing.

Blue Fire Number

The **Blue Fire Number**, which is your address number, is used by **emergency responders** to locate your property. This could save your life or property.
